Testing a Novel Strategy to Improve Implementation of Medication-Assisted Treatment for Veterans with Opioid Use Disorders in Low-Performing Facilities. (AdaPT-OUD)

Principal Investigator/Study Chair: Hildi Hagedorn, PhD, Adam Gordon, MD

Drs. Hildi Hagedorn and Adam Gordon lead the HSR&D-funded ADaPT-OUD (Advancing Pharmacologic Treatment for Opioid Use Disorder) study. This project focuses on increasing access to medication treatment for Veterans with OUD. Administrative data showed that the 35 VA facilities in the lowest quartile of prescribing rates for OUD were prescribing to <21% of patients with an OUD diagnosis at baseline. Eight of these low prescribing VA sites were recruited to receive intensive external facilitation from the ADaPT-OUD team. The remaining 27 low-performing sites continue to receive implementation as usual (e.g., VA Office of Mental Health and Suicide Prevention, and Academic Detailing interventions. As part of the intervention, interviews were conducted with providers to gain insight into barriers and facilitators at each site. An action plan was then tailored to address each site's specific needs and barriers. Each site receives a visit from Dr. Hagedorn and her Co-PI, Dr. Adam Gordon, who provide education and training and work with the site to finalize their action plan. The team is available for expert consultation throughout the intervention as questions arise.

#### **MEDIA**

The Utah State Legislature voted in a special session to replace Proposition 2, known as the Utah Medical Cannabis Act or House Bill 3001 (HB 3001)
